Voting - Any person who is actively employed in the field of paralegal work by a lawyer, law firm, government agency, court or other entity, and who meets one of the following requirements: 1) has one year of working experience as a paralegal; or 2) has six months of working experience as a paralegal and has successfully completed a formal paralegal training program. Voting membership requires that a paralegal's work be supervised by an attorney.

Affiliate - Any person who would otherwise qualify as a Voting Member, except as follows: 1) insufficient length of work experience; or 2) currently unemployed. This would also include anyone else who is not a paralegal.

Student - Any person currently a student enrolled in an approved formal paralegal training program. The student may remain a Student Member for a period of twelve (12) months after graduation (or completion of program).
